

## **BYLAW NO. 266**

---

### **A BYLAW TO ADOPT THE 2017 TO 2021 FINANCIAL PLAN AND CAPITAL EXPENDITURE PROGRAM**

---

**WHEREAS** every regional district must annually adopt a financial plan, by bylaw, which covers the current year and the ensuing four years;

**AND WHEREAS** the Strathcona Regional District wishes to adopt a financial plan which reflects its corporate priorities for the period 2017 to 2021;

**AND WHEREAS** a public consultation process regarding the 2017 to 2021 financial plan has been completed;

**NOW THEREFORE** the Board of Directors of the Strathcona Regional District, in open meeting assembled, enacts as follows:

#### **Financial Plan and Capital Expenditure Program**

1. Schedule A (Consolidated Revenue), Schedule B (Consolidated Expense), Schedule C (Capital Expense and Sources of Revenue) and Schedule D (Revenue and Expense by Service), all of which are attached hereto and form an integral part of this bylaw, are hereby designated and adopted as the financial plan and capital expenditure program for the period commencing January 1, 2017 and terminating on December 31, 2021.
