RE: **BYLAW NO. 652 – PROPOSED YOUTH SUPPORT SERVICE (CORTES ISLAND)**

PURPOSE/PROBLEM

To consider the ballot question to be asked of electors regarding Bylaw No. 652 which proposes to establish a service for the support of youth in Electoral Areas B (Cortes Island).

EXECUTIVE SUMMARY

At its June 24, 2026 meeting the Board considered the attached report and gave Bylaw No. 652 first 3 readings. The Board also passed the following resolution:

Vonesch/Mawhinney: SRD 609/26

THAT approval of the electors for Bylaw No. 652 be sought through an assent voting process to be held concurrently with the 2026 local government elections.

Bylaw No. 652 has now been approved by the Province and it would be appropriate to determine the question to be decided by electors. Once that has been decided the printing of ballots and other voting arrangements can be finalized to ensure that the question can be the subject of voting by electors concurrently with the 2026 local government elections

2. THAT the ballot question to be asked of electors when voting on Bylaw No. 652 be confirmed as follows:

“Are you in favour of Bylaw No. 652 which would establish a service to support youth organizations within Electoral Area B (Cortes Island) provided that the maximum amount that can be requisitioned annually by property taxation is \$0.054 per \$1,000 of land and improvement assessments for regional hospital district purposes.”

AND WHEREAS the Regional Board wishes to establish a service to provide financial assistance for programs and initiatives that serve the interests of youth within Electoral Area B (Cortes Island);

AND WHEREAS the assent of the electors has been obtained in accordance with Division 4 of Part 10 of the *Local Government Act*;

NOW THEREFORE the Board of Directors of the Strathcona Regional District, in open meeting assembled, enacts as follows:

Service Established

1. There is hereby established a service to be known as the youth support service.

Definitions

2. In this bylaw, unless the context otherwise requires:

“youth” means a person who is a resident of Cortes Island and less than 24 years of age.

“organization” means a society, institute, foundation or other similar entity that is incorporated under the laws of British Columbia.

Service Described

3. The service hereby established includes the provision of financial support to organizations that provide services or programs for youths including:
 - a) after-school and educational programming;
 - b) recreation, arts, and cultural activities;
 - c) leadership and mentorship opportunities;
 - d) food security initiatives;
 - e) transportation and accessibility supports;
 - f) wellness, social connection, and mental health supports;
 - g) childcare and family supports;

- h) environmental and outdoor education;
- i) volunteer and community engagement initiatives for youth;
- j) youth outreach and inclusion initiatives;

- n) capacity building within organizations that support, engage or provide services benefiting youth and families;
- o) collaborative community initiatives, pilot projects and emerging community needs related to youth well-being.

Participating Area

Service Area Boundaries

5. The boundaries of the service area include the entirety of Electoral Area B (Cortes Island).

Cost Recovery

6. The annual cost of the service shall be recovered by one or more of the following methods:
- (a) property value taxes imposed in accordance with Division 2 of Part 11 of the *Local Government Act*;
 - (b) revenues received by way of agreement, enterprise, gift, grant or otherwise;
 - (c) revenues raised by other means authorized by the *Local Government Act* or another Act.

Annual Limit on Requisition

7. The maximum amount that may be requisitioned annually for the service is the equivalent of \$0.054 per 1,000 of the net taxable value of land and improvements in the service area.

Citation

8. This bylaw may be cited for all purposes as Bylaw No. 652, being Youth Support Service Establishing Bylaw 2026.

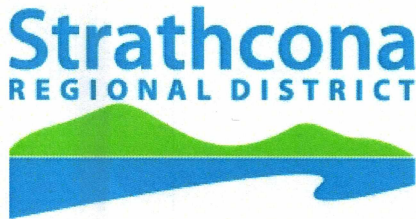

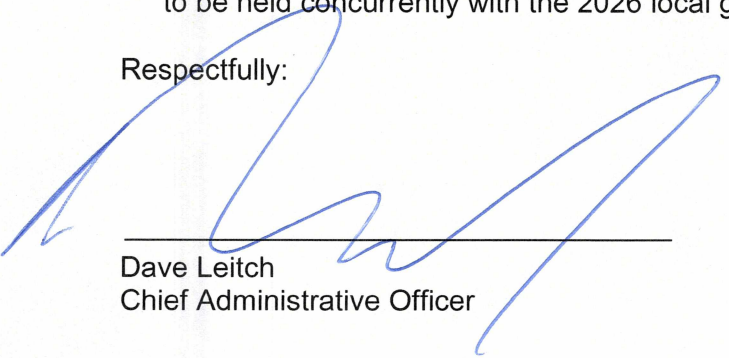
THAT the Committee recommend that Bylaw No. 652 be forwarded to the Board for its consideration.

The attached bylaw has been prepared for the Committee's consideration in accordance with the Board's service initiative processing bylaw which states that new service proposals that affect electoral areas only must be considered by the Electoral Areas Services Committee before being presented to the Board.

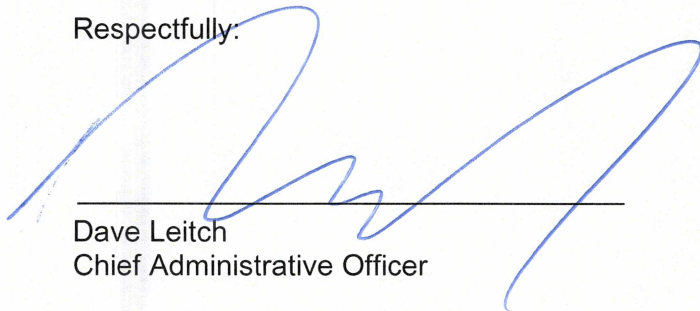
The intent of the youth organization support service is to provide financial support to organizations that serve the interests of youth on Cortes Island. Youth is defined as residents of Cortes Island who are younger than 19 years of age. Financial support would presumably be made by grants in aid whether awarded in response to requests from an eligible organization or under the terms of a contract for services.

Once the Committee is satisfied that Bylaw No. 652 is in order it will be presented for the Board's consideration. If the intent is to seek the assent of the electors for Bylaw No. 652 concurrent with the 2026 director elections, it would be prudent to schedule the Board's review as soon as possible so that it can be presented to the Ministry of Municipal Affairs without delay.

Cortes Youth Service

Background

As a remote community Cortes Island youth have fewer opportunities for youth-focused supports than young people in larger or more connected communities. This impacts families and young people’s mental health and wellness. Cortes has a strong and ongoing need for accessible youth programming, including after-school activities, extracurricular opportunities, supplies, equipment, and related supports that help local youth build confidence, connection, skills, and a sense of belonging in their community and the outside world.

At present, much of this work is supported through Grant-in-Aid funding and other adhoc grants; however, youth programming is not a one-time or occasional need, but a core community service that benefits families, schools, volunteers, local organizations, and the broader island. Establishing a dedicated Youth Service for Cortes Island would provide a stable, transparent, and locally accountable funding source, reducing reliance on annual discretionary grants and allowing better long-term planning for programs and partnerships. The service would create meaningful, sustained investment in the wellbeing of local youth at a modest cost to taxpayers, while recognizing that supporting young people is essential to the social health, resilience, and future of the island community.

BYLAW NO. XXX

A BYLAW TO AUTHORIZE THE PROVISION OF A YOUTH SERVICE WITHIN PART OF THE REGIONAL DISTRICT

WHEREAS the Regional District may, pursuant to the Local Government Act, operate any service that it considers necessary or desirable for all or a part of the Regional District;

AND WHEREAS the Strathcona Regional District wishes to establish a youth service within Electoral Area B;

AND WHEREAS the approval of the electors has been obtained pursuant to Section 342 of the Local Government Act;

NOW THEREFORE the Board of Directors of the Strathcona Regional District, in open meeting assembled, enacts as follows:

Service Established

1. There is hereby established a service to be known as the Cortes Youth Service.

Description of Service

2. The service authorized by this bylaw includes supporting youth serving organizations on Cortes Island with funding for:

- a) after-school and educational programming;
- b) recreation, arts, and cultural activities;
- c) leadership and mentorship opportunities;
- d) food security initiatives;
- e) transportation and accessibility supports;
- f) wellness, social connection, and mental health supports;
- g) childcare and family supports;
- h) environmental and outdoor education;
- i) volunteer and community engagement initiatives for youth;
- j) youth outreach and inclusion initiatives;
- k) intergenerational programming;
- l) Indigenous cultural programming and learning opportunities;
- m) staffing, coordination, administration, training, and operational capacity related to youth well-being;
- n) capacity building within organizations that support, engage, or provide services benefiting youth and families;
- o) collaborative community initiatives, pilot projects, and emerging community needs related to

youth well-being.
