- Has been a resident of British Columbia, as determined in accordance with section 67 of the *Local Government Act*, for at least six months immediately preceding today's date.
- Is not disqualified under the *Local Government Act* or any other enactment from being nominated for, being elected to or holding office as a Director or otherwise disqualified by law.

A nominator **MUST** be a qualified elector of the electoral area where the candidate is running. Elector qualifications are listed in section 65 of the *Local Government Act*.
