



BYLAW NO. 643

A BYLAW TO AMEND THE STRATHCONA GARDENS RECREATION CENTRE SERVICE

WHEREAS the former Comox-Strathcona Regional District has, by Bylaw No. 1214, established a service to provide recreation facilities and programs at the Strathcona Gardens recreation facility;

AND WHEREAS the aforementioned service was transferred to the Strathcona Regional District by supplementary letters patent effective February 15, 2008;

AND WHEREAS the City of Campbell River and Electoral Area D are participants in the Strathcona gardens recreation facility service;

AND WHEREAS Regional Board wishes to amend the provisions of the said recreation facility service by including a portion of Electoral Area C into the service area;

AND WHEREAS the approval of the electors has been obtained pursuant to section 349 of the *Local Government Act*;

NOW THEREFORE the Board of Directors of the Strathcona Regional District, in open meeting assembled, enacts as follows:

Amendments

1. 1) Section 1 of Bylaw No. 1214 is amended by deleting the words “for Electoral Area D and the District of Campbell River” so that the section reads as follows:

1. The area created under supplementary Letters Patent dated February 19, 1971 and March 9, 1977 is hereby established as a local service and shall be known as the “Strathcona Gardens Recreation Centre Service Area”.

- 2) A new section 1C is added to Bylaw No. 1214 as follows:

Participating Areas

- 1C. The City of Campbell River, Electoral Area C and Electoral Area D are participants in the Strathcona Gardens recreation centre service.

- 3) A new section 1D is added to Bylaw No. 1214 as follows:

Service Area Boundaries

1D. The boundaries of the service area shall include the entirety of the City of Campbell River, Electoral Area D and that part of Electoral Area C shown outlined on Appendix 'A', attached to and forming part of this bylaw.

3) Section 3 is deleted in its entirety and a new section 3 is substituted therefor as follows:

Apportionment of Costs

3. The amount to be recovered by requisition shall be calculated on the basis of the converted values for hospital purposes in the participating areas as follows:

- a) City of Campbell River – 100% of property assessments,
- b) Electoral Area D – 90% of property assessments, and
- c) That part of Electoral Area C included as a participating area for the service – 80% of property assessments.

2. This bylaw may be cited for all purposes as Bylaw No. 643, being Strathcona Gardens Recreation Centre Service Establishment Bylaw 1990, Amendment No. 3.
