**BYLAW NO. 28**

**A bylaw to amend the rates for collection of residential refuse  
in the Cortes Island solid waste local service area**

**WHEREAS** the board of the Regional District of Comox-Strathcona adopted Bylaw No. 1903 being "Electoral Area 'I' Solid Waste Local Service Area Regulations and Rates Bylaw 1997" on the 12th day of December 1996;

**AND WHEREAS** the board wishes to increase the annual fee for collection of residential refuse from \$79.00 per year to \$92.00 per year and the rate per collection will remain \$5.00;

**NOW THEREFORE** the board of the Strathcona Regional District in open meeting assembled enacts as follows:

**Amendment**

1. Bylaw No. 1903 being "Cortes Island Solid Waste Local Service Area Regulations and rates Bylaw 1997" is hereby amended by
  - a. Deleting schedule 'B' and replacing with the attached schedule 'B' therefore.
  - b. Change all references of "Electoral Area 'I'" to "Cortes Island", throughout the bylaw.



**Schedule 'B'**

Fees for collection of residential refuse for  
approved receptacles and excess approved receptacles

One (1) approved receptacle per dwelling unit	\$92.00 per year
Each approved receptacle over one (1) approved receptacle per dwelling unit	\$5.00 per collection
