



BYLAW NO. 196

A BYLAW TO ESTABLISH A SERVICE TO FINANCE AN EXTENSION TO THE QUATHIASKI COVE COMMUNITY SEWER SYSTEM

WHEREAS the former Comox-Strathcona Regional District has, by Bylaw No. 1588, established a service to provide a community sewer system for Quathiaski Cove;

AND WHEREAS the Strathcona Regional District wishes to establish a service to finance an extension to the sewer system;

AND WHEREAS the assent of the electors within the proposed extension area has been obtained pursuant to Section 801.2 of the *Local Government Act*;

NOW THEREFORE the Board of Directors of the Strathcona Regional District, in open meeting assembled, enacts as follows:

Service Establishment

1. There is hereby established a service to be known as the Quathiaski Cove Community Sewer Service Extension No. 1.

Participating Area

2. Electoral Area C is the sole participating area for the service established by this bylaw.

Service Area

3. The service area for the Quathiaski Cove Community Sewer Service, Extension No. 1 shall comprise that part of Electoral Area C shown outlined in bold on Appendix 'A', attached to and forming part of this bylaw.

Service Defined

4. The Regional District may undertake and carry out, or cause to be carried out, a community sewer system extension and do all things necessary or convenient in connection therewith including, without limiting the generality of the foregoing, developing a sewage collection system for the benefit of properties within the extension area.

Cost Recovery

5. The annual net cost of operating the service shall be recovered by parcel taxes imposed in accordance with Division 4.3 of Part 24 of the *Local Government Act*.

Requisition Limit

6. The maximum amount that may be requisitioned annually for the service is \$28,500 (Twenty-Eight Thousand, Five Hundred Dollars).

Citation

6. This bylaw may be cited for all purposes as Bylaw No. 196, being Quathiaski Cove Community Sewer Service Extension (No.1) Establishing Bylaw 2014.
