



BYLAW NO. 215

A BYLAW TO AMEND THE BOUNDARIES OF THE SERVICE AREA FOR THE QUATHIASKI COVE SEWAGE LOCAL SERVICE

WHEREAS the former Comox-Strathcona Regional District has, by Bylaw No. 1588, established a service to provide a community sewer system for Quathiaski Cove;

AND WHEREAS an establishing bylaw of the former Comox-Strathcona Regional District that authorizes the operation of a service within all or part of the area comprising the Strathcona Regional District remains in force as an establishing bylaw of the Strathcona Regional District until amended or repealed;

AND WHEREAS the Regional Board wishes to extend the boundaries of the service area and amend certain other provisions of the aforesaid Bylaw No. 1588;

AND WHEREAS a petition has been received from the owners of real property affected by the proposed boundary extension and has been certified as sufficient pursuant to s. 797.4 of the *Local Government Act*;

NOW THEREFORE the Board of Directors of the Strathcona Regional District, in open meeting assembled, enacts as follows:

Amendments

1. Bylaw No. 1588 is hereby amended by:
 - (a) deleting the words "Electoral Area J" in the long title and substituting the words "part of Electoral Area C".
 - (b) deleting the words "Electoral Area J" in Section 1 and substituting the words "Electoral Area C".
 - (c) adding the properties shown outlined in bold on Appendix 'A', attached to and forming part of this bylaw, to the service area.

2. This bylaw may be cited for all purposes as Bylaw No. 215, being Quathiaski Cove Sewage Local Service Area Establishment Bylaw 1993, Amendment No. 4.




