



## BYLAW NO. 335

---

### A BYLAW TO AUTHORIZE THE ACQUISITION OF COMMUNITY PARKLAND WITHIN ELECTORAL AREA C

---

**WHEREAS** the former Comox-Strathcona Regional District has, by Bylaw No. 2097, established a community parks service applicable to Electoral Area J of that regional district;

**AND WHEREAS** a bylaw of the aforesaid Comox-Strathcona Regional District that authorizes the operation of a service within all or part of the area comprising the Strathcona Regional District remains in force as a bylaw of the Strathcona Regional District;

**AND WHEREAS** the service established by Bylaw No. 2097 applies to that part of the Strathcona Regional District located within the boundaries of Electoral Area C (Discovery Islands-Mainland Inlets);

**AND WHEREAS** the Regional Board wishes to authorize the acquisition of land located at Hyacinthe Bay on Quadra Island as community parkland;

**NOW THEREFORE** the Board of Directors of the Strathcona Regional District, in open meeting assembled, enacts as follows:

#### **Acquisition Authorized**

1. The Regional District is hereby authorized to acquire the real property located on the north shore of Hyacinthe Bay, Quadra Island and legally described as that part of Block A of District Lot 225, Sayward Land District, lying to the west of the production southerly of the easterly boundary of District Lot 137 (PID 009-013-423).

#### **Parkland to be Managed as Nature Sanctuary**

2. The real property acquired under the authority of this bylaw shall be designated as community parkland, to be held and managed as a nature sanctuary, upon adoption of this bylaw.

#### **Authority to Execute Agreements**

3. The Chair and Corporate Officer shall have full authority to execute such contracts, agreements, covenants and other documents as may be required to give effect to the authorities contained herein.

**Effective Date**

4. This bylaw shall come into effect on the day of its adoption.

**Citation**

5. This bylaw may be cited for all purpose as Bylaw No. 335, being Hyacinthe Bay Nature Sanctuary Acquisition Authorization Bylaw 2018.


